MINUTES OF THE 77^{TH} MEETING OF BOARD OF GOVERNORS HELD AT 11.30 AM ON 20^{TH} JUNE, 2007 IN THE CONFERENCE HALL, ROOM NO. 112, 'C' WING SHASTRI BHAWAN, NEW DELHI.

The Hon'ble HRM & Chairman, KVS presided over the 77th meeting of the Board of Governors of Kendriya Vidyalaya Sangathan held on 20th June, 2007 at 11.30 AM in Shastri Bhawan, New Delhi. The list of members and special invitees who attended the meeting is at Annexure – 'A'

The Commissioner, KVS, welcomed the Chairman, KVS & the newly nominated members, viz., Smt Prema Cariappa, MP[Rajya Sabha] and Shri M.Kutralingam, Secretary Secondary Education, Govt of Tamil Nadu. He also welcomed Smt Zoya Hassan, Major General S.S.Nair, Commodore H S Bhaktavatsala, VSM and Air Commodore Satyendra Kumar who participated in the Board meeting for the first time, and other distinguished members of the Board.

Reporting the achievements of the students of Kendriya Vidyalayas in the CBSE Board examinations of classes X and XII which have been compiled based on the analysis of the CBSE results, Commissioner informed that the pass percentage in CBSE class X examination rose from 90.63% in 2006 to 95.64% in 2007 registering an increase of 5.01%. The class XII result registered an increase of 0.25% from the previous year as the pass percentage improved from 92.89% to 93.14% in 2007. Kumari Aparna Muralidhar of Kendriya Vidyalaya ASC Centre Bangalore has topped the class X CBSE Board with 99% securing 495/500 marks and Kumari Roshni Bano of Kendriya Vidyalaya IIT Powai, Mumbai is the KVS topper with 490/500 marks, a close second to the topper of CBSE who has secured 491 marks, in the CBSE exam.

In qualitative terms also Kendriya Vidyalayas has registered an increase in the number of students securing more than 90% marks both in class X & class XII. The total number of students getting merit certificates rose from 507 in 2006 to 1158 in 2007 in class X while in class XII, the increase has been from 373 to 426.

Achievements by the KV students in other fields were also highlighted. Out of five K.V. students selected for Indian National Mathematics Olympiad 2007, one student, Master Utkarsh Tripathi of K.V. IIT, Kanpur has been selected for International Mathematical Olympiad 2007 team by the National Board of Higher Mathematics to be held at Hanoi, Vietnam. Similarly, Master Rohit Singh has been selected for participation in the International Physics Olympiad to be held in Iran.

Commissioner, KVS further informed that in the Brand Equity survey in the field of education by the Economic Times, KVS has been rated as no.1 followed by other educational institutions of repute.

Commissioner, KVS further informed that out of 50 Vidyalayas opened in the Special Focus Districts during 2006-07, 12 could not be made functional due to lack of infrastructural facilities to be provided by the Sponsoring Agencies and the remaining 38 have started their academic session in 2007-08.

Hon'ble HRM and Chairman, KVS desired that both the toppers of Sangathan in class X and

class XII Board examinations be felicitated and suitably recognized for their spectacular achievements with a view to inspiring other students.

Thereafter the agenda items listed for deliberations were taken up by the Member-Secretary for consideration of the Board.

ITEM NO.1 CONFIRMATION OF THE MINUTES OF THE 76TH MEETING OF THE BOARD OF GOVERNORS HELD ON 4.12.2006.

The Board confirmed the minutes of the 76th meeting of the Board of Governors held on 4.12.2006.

ITEM NO. 2 ACTION TAKEN REPORT ON THE MINUTES OF THE 76TH MEETING OF THE BOARD OF GOVERNORS HELD ON 4.12.2006.

The Board noted the actions taken pursuant to the decisions of the Board taken in its meeting held on 4.12.2006.

Against item No.5 of the Action Taken Report, the Board was informed that the MOU had already been signed between ICICI Bank and KVS which would be effective from 1st July,2007.

ITEM NO. 3 RATIFICATION OF DECISIONS TAKEN BY CHAIRMAN, KVS 3[I] KVS INCENTIVE AWARD TO NON-TEACHING STAFF

The Board ratified the decision taken by the Chairman, KVS to confer five non-teaching employees of the Sangathan with KVS Incentive Award every year as per recommendations of the Committee constituted for this purpose.

3[II] ACCEPTANCE OF LAND FOR THE INITIAL LEASE PERIOD OF 40 YEARS WITH PROVISION FOR RENEWAL UPTO 99 YEARS IN RESPECT OF KVs LOCATED IN THE STATE OF J&K

The Board ratified the decision taken by the Chairman, KVS to accept land in respect of civil sector KVs in the state of J&K for an initial period of 40 years with provision for renewal upto 99 years

3[III] AMENDMENT IN COMPOSITION OF D.P.C. FOR THE POSTS OF DEPUTY COMMISSIONER (ACAD.)/(TRG.) AND DEPUTY COMMISSIONER (ADMN.) /(PERSONNEL).

The Board ratified the decision taken by the Chairman, KVS to amend the composition of the D.P.C. for the posts of Deputy Commissioner (Acad.)/(Trg,) and Deputy Commissioner (Admn.)/(Pers.) by virtue of which the Chairman of the said Committee would be Vice-Chairman, KVS instead of Additional Secretary[Edn].

3[IV] APPOINTMENT OF JOINT COMMISSIONER [ADMN] –RELAXATION IN RECRUITMENT RULES

The Board ratified the decision taken by the Chairman, KVS in relaxing the Recruitment Rules of KVS in the appointment of Smt Pragya Richa Srivastava as Joint Commissioner [Admn], KVS.

3[V] CONSTITUTION OF REVIEW COMMITTEE FOR REVIEW OF SUSPENSION CASES IN RESPECT OF GROUP 'A' OFFICERS.

The Board ratified the decision taken by the Chairman to constitute a Review Committee consisting of JS[SE]& Vice-Chairman, KVS, Commissioner, KVS and Commissioner, NVS to review the suspension cases in respect of Group 'A' Officers of KVS.

ITEM NO. 4 ADOPTION OF ANNUAL ACCOUNTS OF KVS FOR THE YEAR 2006-07 The Board approved and adopted the Annual Accounts of the Sangathan for the year 2006-2007 to be submitted to DGACR for audit.

ITEM NO 5 APPROVAL OF THE RECOMMENDATIONS OF THE FINANCE COMMITTEE MEETING HELD ON 13.6.2007

The Board approved the recommendations made by the Finance Committee in its meeting held on 13th June, 2007.

ITEM NO 6 APPROVAL OF THE RECOMMENDATIONS OF THE ACADEMIC ADVISORY COMMITTEE MEETING HELD ON 29TH MAY 200

The Board approved the recommendations made by the Academic Advisory Committee in its meeting held on 29th May, 2007.

However, while deliberating on item no3 of the minutes of the aforesaid meeting of the Academic Advisory Committee, Prof Satyanarayana suggested for extending reciprocal benefit to the Kendriya Vidyalaya students in the matter of granting them admission on the basis of Transfer Certificate in the schools run by Armed Forces.

Shri A.K.Balyan also raised the issue of according over-riding priority in the grant of admission in ONGC sponsored KVs to the wards of ONGC employees even though such employees come on transfer at a belated stage.

It was decided that these matters should be examined at length and a suitable proposal be submitted for the consideration of the Chairman, KVS.

ITEM NO 7 APPROVAL OF THE RECOMMENDATIONS OF THE WORKS COMMITTEE MEETING HELD ON 8^{TH} JUNE 2007

The Board approved the recommendations made by the Works Committee in its meeting held on 8th June, 2007.

However, against Item No.6 the Board observed that transfer of land in advance may be substituted with "Identification/ demarcation of land at site subject to its transfer in favour of KVS within one year".

ITEM NO 8 DECLARING THE STATIONS AS HARD / VERY HARD STATIONS WHERE KENDRIYA VIDYALAYAS ARE LOCATED

The Board approved the list of Hard/Very Hard stations notified by KVS as per Appendix-'A'.

ITEM NO 9 OPENING OF NEW KENDRIYA VIDYALAYA AT TWO LOCATIONS HAVING FEASIBLE PROPOSALS

The Board approved inclusion of two locations in Gandhigram, Distt Dindigul and Pathanamthitta for opening of Kendriya Vidyalayas in the list of feasible proposals.

ITEM NO 10 PROPOSAL FOR CLOSURE OF KENDRIYA VIDYALAYA, KABUL The Board approved the proposal for closure of Kendriya Vidyalaya Kabul w.e.f.1.1.1989.

ITEM NO 11 APPROVAL OF THE RECOMMENDATIONS OF THE COMMITTEE CONSTITUTED TO FORMULATE A POLICY FOR OPENING OF KENDRIYA VIDYALAYA IN

FOREIGN COUNTRY

The proposal was discussed at length. It was decided to further examine the issue in detail for formulating a final policy in the matter.

ITEM NO 12 PROPOSAL FOR AMENDMENT OF RECRUITMENT RULES FOR THE POST OF HEADMASTER UNDER SERIAL NUMBER 14 OF SCHEDULE-I OF KV (APPOINTMENT, PROMOTION, SENIORITY ETC.) RULES, 1971.

The proposal to amend the Recruitment rules for the post of Headmaster as per Appendix-'B' was approved by the Board.

ITEM NO 13 REVISION OF NORMS FOR THE REQUIREMENT OF LAND FOR THE KENDRIYA VIDYALAYAS UNDER PROJECT SECTOR AND INSTITUTE OF HIGHER LEARNING

The Board approved the revision of norms for requirement of land for opening of KVs under Project Sector/ Institute of Higher Learning by adopting the existing norms for opening of KVs under Civil Sector/ Defence Sector.

ITEM NO 14 PROVISION FOR SIGNING OF MEMORANDUM OF UNDERSTANDING FOR KENDRIYA VIDYALAYAS UNDER PROJECT SECTOR AND INSTITUTE OF HIGHER

LEARNING

The Board approved the MOUs to be executed between sponsoring authorities and KVS for opening of new Kendriya Vidyalayas and also for the established KVs under Project Sector/ Institute of Higher Learning sector with inclusion of clauses as per recommendations made by the Finance Committee in respect of recovery of administrative overhead charges @ 15% of the actual expenditure from the Project Vidyalayas and also introduction of penal interest @2% per month for delayed payment.

SUPPLEMENTARY AGENDA ITEMS

ITEM NO 1 CONSITUTION OF 'ADMINISTRATION & ESTABLISHMENT COMMITTEE'- A STANDING COMMITTEE OF THE KVS

The Board approved the constitution of an 'Administration & Establishment Committee' as a Sub-committee of the Board of Governors. The composition and functions of the said Committee shall be as specified below:

FUNCTIONS:

(i) To advise the Sangathan about the policies to be introduced on administrative and establishment matters and the means to regulate and monitor those policies effectively.

- (ii) To help prepare guidelines in matters of e-governance, settlement of grievances and monitoring of other redressal machinery.
- (iii) To bring about effective coordination among the various units of the organization at various levels.

COMPOSITION:

The 'Administration & Establishment Committee' shall consist of 6 members as follows:

Vice-Chairman, KVS -Chairman
 A representative of the M/HRD -Member
 A representative of DOPT -Member
 Commissioner, KVS -Member
 Joint Commissioner [Admn] -Member

6. Deputy Commissioner [Admn/ Pers] -Member Secretary

ITEM NO 2 POWERS EXERCISED BY PRESIDENT UNDER RULE 9 OF THE CCS (PENSION) RULES, 1972 TO BE EXERCISED BY CHAIRMAN, KVS.

The Board approved the following proposals:

- a) The powers conferred upon the President of India under Rule 9 of the CCS (Pension) Rules, 1972 fall within the domain of the Chairman, K.V.S. as he is the appropriate authority to exercise those powers as has been done in the past and in the present as the same is in accordance with THE GOVERNMENT OF INDIA (ALLOCATION OF BUSINESS) RULES.
- b) In exercise of powers conferred upon the Chairman, K.V.S. under Article 12 of the Education Code, all decision taken and orders passed in the past under Rule 9 of the CCS (Pension) Rules, 1972 by Chairman, K.V.S. in the disciplinary cases/other cases in respect of retired employees of K.V.S. are approved as the same have been taken in proper exercise of powers vested in the Chairman, K.V.S.

ITEM NO 3 ADMISSION UNDER SPECIAL DISPENSATION QUOTA OF HON'BLE HRM

The Board ratified the action of the Chairman, KVS regarding constitution of a new committee to consider requests seeking admission in Kendriya Vidyalayas under Special Dispensation for granting admissions during 2007-08.

The meeting ended with a vote of thanks to the Chair.
