

## MINUTES OF THE 81<sup>ST</sup> MEETING OF BOARD OF GOVERNORS HELD AT 4.00 PM. ON 18.12.2008 IN THE CONFERENCE HALL, ROOM NO. 112, 'C' WING, SHASTRI BHAWAN, NEW DELHI

The Hon'ble Chairman, KVS presided over the  $81^{\rm st}$  meeting of the Board of Governors of Kendriya Vidyalaya Sangathan held on  $18^{\rm th}$  December, 2008 at 4.00 p.m. in Shastri Bhawan, New Delhi. The list of members and special invitees who attended the meeting is at Annexure -`A'

The Commissioner, KVS, welcomed the Chairman, KVS & other distinguished members of the Board. He then brought to the kind notice of all Hon'ble Members that the vacancies of teachers, which was an area of concern during the last meeting of the BOG, has been taken care of by recruiting and posting teachers in the Vidyalayas. He further added that for the first time the enrolment of students in Kendriya Vidyalayas has crossed one million.

The Member Secretary informed the Hon'ble members regarding inauguration of KVS Auditorium known as Dr. Sarvepalli Radha Krishnan Auditorium, by Hon'ble Chairman, KVS on 15<sup>th</sup> December 2008

Thereafter, with the permission of the Chair, the agenda items listed for deliberation were taken up for consideration by the Board.

ITEM NO. 1 CONFIRMATION OF THE MINUTES OF THE 80<sup>TH</sup> MEETING OF THE BOARD OF GOVERNORS HELD ON 26.07.2008.

The B.O.G confirmed the minutes of the 80<sup>th</sup> meeting of the Board of Governors held on 26.07.2008.

ITEM NO. 2 ACTION TAKEN REPORT ON THE MINUTES OF THE 80<sup>TH</sup> MEETING OF THE BOARD OF GOVERNORS HELD ON 26.07.2008.

The B.O.G noted the actions taken pursuant to the decisions taken in its 80<sup>th</sup> meeting held on 26.07.2008.

## ITEM NO.3 RATIFICATION OF THE DECISIONS TAKEN BY CHAIRMAN, KVS:

The decisions taken by the Chairman in respect of the following items were ratified by the B.O.G.

- (A) REGARDING AMENDMENT IN CERTAIN PARAS OF KVS TRANSFER GUIDELINES EFFECTIVE FROM 14.03.2006.
- (B) ADOPTION OF THE CCS (REVISED PAY) RULES, 2008 W.E.F. 01.01.2006 IN THE MATTER OF EMPLOYEES OF KVS BASED ON THE RECOMMENDATION OF 6<sup>TH</sup> PAY COMMISSION.
- (C) ADMISSION UNDER SPECIAL DISPENSATION QUOTA OF HON'BLE HRM FOR 2008-09.

## ITEM NO.4 OPENING OF NEW KENDRIYA VIDYALAYAS IN THREE LOCATIONS HAVING FEASIBLE PROPOSAL

The B.O.G approved opening of three new Kendriya Vidyalayas sponsored by State Governments under Civil Sector viz. Raisen, Distt. Raisen (Madhya Pradesh), Chero, Salempur, Distt. Deoria (Uttar Pradesh) and Quaziabad, Udipora Distt., Kupwara (Jammu & Kashmir)

During deliberation Prof. Mrinal Miri raised an issue regarding the decision taken to open Kendriya Vidyalayas in all Central Universities in the North East. No decision could be arrived at as KVS has not received any decision to this effect. However, it was decided that the matter will be taken up by the Vice Chairman KVS with D.O.N.E.R to explore the possibilities of funding new KVs in N.E.R. ITEM NO. 5 RE-DESIGNATION OF POST OF STATISTICAL ASSISTANT AS STATISTICAL OFFICER CONSEQUENT UPON IMPLEMENTATION OF THE RECOMMENDATIONS OF THE SIXTH PAY COMMISSION IN KVS

The B.O.G approved re-designation of the post of Statistical Assistant as Statistical Officer with continued duties and responsibilities in the Pay Band -2 i.e Rs. 9300-34800 with Grade Pay of Rs. 4200/-. There would be no additional financial burden consequent upon implementation of the recommendations of the Sixth Pay Commission in KVS.
