MINUTES OF THE 84TH MEETING OF THE BOARD OF GOVERNORS OF KVS HELD AT 3.00 P.M. ON 29.7.2009 IN THE CONFERENCE HALL, ROOM NO.112, 'C' WING, SHASTRI BHAWAN, NEW DELHI.

The Hon'ble Minister of Human Resource Development & Chairman, Kendriya Vidyalaya Sangathan presided over the 84th meeting of the Board of Governors held on 29th July, 2009 at 3.00 P.M. in Shastri Bhawan, New Delhi. The list of members and special invitees who attended the meeting is annexed.

Joint Commissioner (Admn.) & the Member-Secretary of the B.O.G. welcomed Shri Kapil Sibal, Hon'ble HRM & Chairman, KVS, Smt. D. Purandeswari, Hon'ble Minister of State & Deputy Chairperson, KVS and other members of the Board

Agenda items were thereafter taken up by the Member Secretary of the Board of Governors with the permission of the Chair.

ITEM NO.1: Confirmation of the minutes of the 83rd meeting of the Board of Governors held on 26.4.2009.

After deliberation on the comments raised by the Hon'ble members of the B.O.G. representing the three Wings of the Defence Establishment, the Board confirmed the minutes of the 83rd meeting of the B.O.G. held on 26.4.2009. The Chairman, KVS desired that admission policy may be examined in respect of the comments given by the representatives of Armed Forces.

ITEM NO.2: Action Taken Report on the minutes of the 83rd meeting of BOG held on 26.4.2009 and present status of the decision where action has not been concluded.

The Board noted the actions taken pursuant to the decisions of the Board taken in its meeting held on 26.4.2009 and the status of the decisions taken in previous Board meetings where actions have not been concluded. While deliberating the issues the Member Secretary informed the Board about the status of the "KVNET" project. Chairman, KVS desired that the necessary formalities to award the work be completed quickly so that the project implementation could begin in the next 6 to 8 months. The Commissioner, KVS submitted that around 90% KVs have broadband connectivity and for the remaining 10% KVs VSAT connections will be utilized temporarily. However, it is practicable to start implementation of the Project within the next 6 months.

ITEM NO.3: Ratification of the decision taken by the Chairman, KVS.

(i) Appointment of Shri Ashwani Kumar as APS in the Ministry of HRD against the vacant post of Administrative Officer, KVS.

The Board ratified the approval of the Chairman, KVS to the appointment of Shri Ashwani Kumar as A.P.S. in the Ministry of HRD against the vacant post of Administrative Officer in KVS.

(ii) Constitution of Review Committees for reviewing suspension cases in respect of Group 'A' Officers of KVS.

The Board ratified the decision taken by the Chairman, KVS on constitution of Review Committees for reviewing suspension cases in respect of Group 'A' Officers of KVS.

(iii) Approval of Annual Accounts of the Kendriya Vidyalaya Sangathan for the year 2008-09.

The Board ratified the approval of the Annual Accounts of KVS for the year 2008-09 by the Chairman, KVS.

(iv) Supplementary agenda item no. 1 - Relaxation of age for admission to class XI in respect of Master Stanzin Chokgyur.

The Board ratified the decision taken by Chairman, KVS relating to relaxation of age for admission to class XI in respect of Master Stanzin Chokgyur.

ITEM NO.4: To confirm the minutes of the meeting of the Works Committee, KVS held on 29.5.2009.

The Board approved the recommendations made by the Works Committee in its meeting held on 29.5.2009. The Chairman further advised that agencies other than the CPWD may be identified for expediting the construction of school buildings. He further advised the members of the

Defence Establishment to formulate a policy whereby it will not be needed to seek cabinet approval for each and every case of transfer of land to KVS on lease basis as the land actually remains with them and utilized by KVS only for the specified purposes.

ITEM NO.5: To confirm the minutes of the meeting of Finance Committee, KVS held on 29.6.2009.

The Board approved the recommendations made by the Finance Committee in its meeting held on 29.6.2009. Further the Board decided to enhance the Fees (V.V.N., Tuition Fees and Computer Fund) w.e.f. 01.10.2009 and desired that V.V.N. should be utilized properly for the betterment of the students.

ITEM NO.6: To confirm the minutes of the meeting of the Academic Advisory Committee, KVS held on 17.7.2009.

The Board approved the recommendations made by the Academic Advisory Committee in its meeting held on 17.7.2009. However, the Board did not agree to the recommendation of Prof. Krishna Kumar Committee on 'Strategy of action plan for realizing the objectives of NCF – 2005 in KVs' recommending 50% reservation for admission to girls at the entry level made vide para-12.2.5. The Board, however, suggested that strategy

should be evolved to ensure that maximum number of girls get admission in KVs. In addition, monetary and other kind of incentives could be given to girl students in form of fees waiver, scholarship for meritorious girl students etc. to encourage retention of the girl students in secondary and senior secondary classes besides giving due recognition to brilliant students.

ITEM NO.7: Opening of new Kendriya Vidyalayas at three locations having feasible proposal.

The Board approved inclusion of three locations namely Krishnarajapuram (Distt. Bangalore); Harnaut (Distt Nalanda) and CISF Mundali (Distt. Cuttack) for opening of Kendriya Vidyalayas, in the list of feasible proposals. The Board also desired that pro-active steps be taken to secure sponsorship from various State Governments so that in the near future the KVS is able to provide Kendriya Vidyalayas to almost all the Districts in this country.

ITEM NO.8: Writing of ACRs of the subordinates by those Superintendents who are re-designated as Section Officers w.e.f. 18.12.2008.

SUPPLEMENTARY ITEM:

Regulation of Child Care Leave (Recommended by VI Pay Commission in schools, ROs and KVS(HQ)

The Board decided that the Govt. of India Rules will be applicable to all women employees of KVS including the teachers in the matter of granting Child Care Leave as recommended by the VI Pay Commission subject to the tollowing conditions:

- (i) The post, from which the Govt. servant will proceed on leave for more than 90 days, will be treated as vacant and the same post can be filled up by the competent authority by another incumbent in the interest of the Vidyalaya.
- (ii) In case the Govt. servant is working in hard/very hard station, the leave period will not be counted for the purpose of completion of tenure in respect of transfer etc.
- (iii) In case the Govt. servant is on probation, the probation period will be extended equivalent to the leave period.
- (iv) The Principal immediate higher Officer (Leave sanctioning authority) will assess the situation before granting such leave to the female employee, keeping in view its genuineness and need as the CCL can not be demanded as a matter of right. Under no circumstances can any employee proceed on CCL without prior sanction of the leave by the leave sanctioning authority.

The Hon'ble HRM in his concluding address stressed on the need to globalize the KV concept either through establishment of KVs abroad or through some sort of participation with other agencies/organization as KVS has been accepted as a pace setter institution in the field of school education. This need for globalization must go hand in hand with changes in our curriculum coupled with flexibility at different levels in order to attract the students and organizations beyond our boundaries. If need be, the required changes could be incorporated in the Memorandum of Association to enlarge the mandate of KVS accordingly. He also stressed upon the pre-service and in-service training of teachers for proper empowerment and professional growth of teachers.

Meeting ended with a vote of thanks to the Chair.
