The approval of the Board of Governors, KVS, accorded in its 91<sup>st</sup> meeting held on 19.01.2012, delegating the revised powers of condemnation of Articles of Stores including the IT equipments is accorded as under:-

a) The powers of condemnation of stores including the IT equipments purchased out of VVN/School fund account at various levels of KVS:


