(RTE compliance and provision of additional staff regarding)

महोदया/महोदय,

In terms of the provisions of the RTE Act 2009 it is envisaged that Pupil-Teacher Ratio (PTR) should not exceed 40:1 for classes I to V and 35:1 for classes VI to VIII respectively. The issue has been discussed in the 91st meeting of BOG held on 19-01-2012 and accordingly decisions taken were conveyed vide letter No.F.110333/1/2011-KVSHQ(Acad.)/Cir-27 dated 17-02-2012 (copy enclosed).

The issue was again discussed in 96th meeting of BOG held on 28-01-2014 and recommendations of AAC for new staff sanction norms to make it RTE compliant have been approved by the Board of Governors (extract Appendix-A is enclosed). The details are also available on www.kvsangathan.nic.in.

Further inputs have been recently obtained from Regional Offices about KVs where Pupil-Teacher is to be made RTE compliant as stated above, vide this office letter dated 05-05-2014. The information received from the Regional Offices has been compiled and sanction of additional posts as per new norms is under process.

Under these circumstances, and as an interim measure, the competent authority has desired to reiterate that suitable instructions be conveyed to the Principals of all KVs to adhere to the provisions of RTE Act 2009 with regard to the Pupil-Teacher ratio. It needs to be ensured that Pupil-Teacher ratio in each Vidyalaya under your jurisdiction remains within the prescribed limit and if need be, additional teachers may be appointed on contractual basis till sanction of regular additional posts as per new norms is conveyed from KVS(HQ). It is pertinent to mention that every KV must ensure that the requirement of posts of teachers are worked out with due care as per the decisions taken in 96th meeting of the BOG in the light of RTE act.

This may be given priority, please.
