Subject:- Revision of rates of messing allowance of cadets/ANOs during NCC Camps including sailing/cycling expeditions

Sir,
I am directed to refer to Govt of India, Ministry of Defence letter No. 3372/Mess Allice/DGNCC/Budget/1022/D(GS-VI)/13 dated 26 Sep 2013 on the above subject and to convey the sanction of the competent authority for the enhancement of Messing Allowance in respect of NCC Cadets and ANOs during NCC Camps including sailing/cycling expeditions to Rs. 150/- (Rupees one hundred fifty only) per NCC cadet/ANO per day.

The expenditure on this account will be shared between the Central Govt. and State Govts/Union Territory Administrations (UTAs) in the ratio of 75:25.

- The revised rate for Messing allowance to Cadets/ANOs shall take effect from the date of issue of this letter.
- Further revision of this rate is subject to variations in the Wholesale Price Index (WPI).
- This issues with the concurrence of Min of Def (Fin/GS) vide their U.O. No. RB/76/Fin(GS-II)/19 dated 01.08.2019.
