Item No. 1: Minutes of 19th Academic Advisory Committee Meeting held on 22nd November, 2001.

No comments were received regarding this meeting from any of the members. The minutes were therefore taken as confirmed.

Item No. 2: Follow up action of 19th meeting of the Academic Advisory

Committee held on November 22, 2001.

Action taken was noted.

Item No. 3: Teaching periods allotted to Principals/Vice Principals and

Headmasters.

The Committee discussed the allotment of weekly teaching periods at length. It was felt that Principals should be allotted some teaching periods so as to keep them in touch with academics. Further the teaching periods will provide an opportunity for closer supervision of teachers and interaction with students. However, keeping in view the additional workload of Principals the number of teaching periods of Principals may be reduced to five from the present eleven. The teaching periods of Vice-Principals and Headmasters would remain unchanged.

ITEM NO.03 TEACHING PERIODS ALLOTTED TO PRINCIPALS / VICE-PRINCIPALS AND HEADMASTERS

The Principals, Vice-Principals and Head-Masters of Kendriya Vidyalayas are being allotted weekly teaching periods in various classes as under, since inception of Kendriya Vidyalaya Sangathan.

Since 2000-2001, for the close academic Inspection / Supervision in teaching taking place, at least one class room each is to be observed everyday by the Principal, Vice-Principal and Head-Master on daily basis in a manner that all classes, including Primary classes and all subjects come within pin-pointedly in a diary. With introduction of Informatics Practices at Plus-2 level and Computer Education in lower classes, the work-load of Inspection / Supervision has increased considerably. In addition, the Principal has been given additional responsibilities like Construction, Repairs and Maintenance of the Vidyalaya and also many other activities under Vidyalaya Vikas Nidhi.

Keeping in view the Inspection / Supervision and other activities related to workload of the Principals, Vice-Principals and Head-Masters, it is proposed to re-consider the allotment of weekly teaching periods to them as mentioned above, in order to make the workload reasonably systematized.
