| 14 | The of post of Art teacher will be sanctioned in a KV having at least one section each from class I to X. |
| 15 | New post of Yoga teacher is not to be sanctioned, however, existing Yoga teacher will continue. |
| 16 | The post of Librarian will be sanctioned in a KV having class-VI onwards. |
| 17 | Periods allotted to the Principal – 5 per week. Not to be calculated in total workload. |
| 18 | Periods allotted to the Vice Principal -22 per week. Not to be calculated in total workload. |
| 19 | During sanction of any teaching post for common subjects the actual workload of teacher and students in a class should be taken into |
| 12 | account. (for eg. in English class-XI(Sc.) there are 10 students and XI(Com.) there are 6 students then both the classes can be merged together. |
| 20 | Period of other category of teachers (like: PRT-Music/TGT(P&HE)/ TGT(AE)/TGT(WE), Librarian and existing Yoga teachers also) may |

| 22 | For students of classes XI and XII who have not opted Computer Science/IP, Computer literacy can be provided during Work Education and General Studies Classes. |
| 23 | Proposal for sanction of new stream at +2 levels or additional sections should be sent duly approved by Chairman, VMC subject to the, availability of suitable and safe infrastructure. |
| 24 | The staff sanction strength of a KV will not change after the redistribution of periods allotted to scholastic and co-scholastic subjects. Instructions have already been issued in this regard vide letter No. 110333/1/2011-KVSHQ(Acad)/Time-Table/3406-07 dated 04.08.2014. |
| 25 | Regional offices to ensure that proposals of all KVs should be sent within the prescribed time in one go only making three different bunches for Civil, Defence and Project KVs separately. Piece meal proposals will not be entertained. |
| 26 | In case of consequential/additional increase in Class XI workload of teachers should be calculated by adding the periods of Class XII also. |
| 27 | Only one post of PGT (Bio) will be sanctioned up to the full strength of one section, however, if number of sections increases, than additional post of PGT(Bio) may be sanctioned and the post of TGT(Science) may be increased/decreased accordingly. |
| 28 | Additional post of PGT (Computer Science) can be sanctioned on the basis of actual workload of Computer Science and IP in +2 Classes |
| 29 | Up to 3 section KVs(i.e. I to X-3 section in each class). Post of Assistant-1/UDC-1/LDC-1will be sanctioned. |
| 30 | Up to 4 section KVs(i.e. I to X-4 section in each class). Post of Assistant-1/UDC-1/LDC-2 will be sanctioned. |
| 31 | Up to 5 sections and above KVs (.e. I to X-5 section in each class). Posts of Asst1/UDC-2/LDC-2 will be sanctioned. |
| 32 | During calculation of sub staff in a KV the provision of ratio of outsourcing and regular sub staff must be kept in the mind. |
| 32 | Burning character of and LDC and Cub staff 9, and Nurse or the Videralaya having bestel facilities will continue |
